### 4. First-Aid Measures

**General advice:**

First aid providers should wear personal protective equipment to prevent exposure. Remove contaminated clothing. Move person to fresh air. If person is not breathing, call 911 or ambulance, then give artificial respiration, preferably mouth-to-mouth if possible. Call a poison control center or physician for treatment advice. ### 5. Fire-Fighting Measures

### **Cleanup:**

After decontamination, spill area can be washed with water. Collect wash water for approved disposal.

## 7. Handling and Storage

### **Handling**

#### **General advice:**

RECOMMENDATIONS ARE FOR MANUFACTURING, COMMERCIAL BLENDING, AND PACKAGING WORKERS. PESTICIDE APPLICATORS & WORKERS must refer to the Product Label and Directions for Use attached to the product. **Hand protection:**
